Positions in class 5268 Architect are distinguished from those in class 5270 5211 Engineer/Architect/Landscape Architect Senior in that the latter class may have major responsibility over a large group of subordinates and numerous, projects of varying scope, whereas employees in class 5268 Architect are normally responsible for one major project or several smaller projects of varying scope and a moderate size group of subordinates.
