Other Updates

Public Transit

Beginning today, March 30, all Muni Metro and light rail routes will be replaced by buses (J/KT/L/M/N). Metro subway stations will be closed, except for downtown stations which will remain open for BART service during their operating hours. Customers may use the same bus stops as the early morning Metro

bus service.

Priority COVID-19 Testing for First Responders and Health Care Workers

All San Francisco Health Service System health plans—Kaiser Permanente, Blue Shield of California and United Healthcare—will prioritize COVID-19 testing for all City first responders and healthcare workers who have confirmed COVID-19 symptom to ensure our frontline employees have access to testing. The City will continue to advocate for and leverage available local, state, and federal resources to expand testing.

Update on Expedited Nurse Hiring

San Francisco has been experiencing a shortage of nurses in our public hospitals. At the direction of Mayor Breed and through a partnership with the Department of Public Health and the Department of Human Resources, the City has expedited hiring for nurses to fill nearly 200 vacancies. Over the last two weeks, DPH has held hiring events to fill these vacancies. **To date, we have hired 82 registered nurses to fill a number of critical positions in the Emergency Department, ICU, and other units.**

Calling Licensed Medical Professionals: Emergency Volunteer Center (EVC)

The Department of Public Health (DPH) is offering a unique opportunity for licensed health professionals to volunteer their talents and experience to fight against COVID-19. From physicians to nurses to EMTs to therapists and other medical professions, there will be roles for all types of licensed medical professionals.
