DISTINGUISHING FEATURES

The 3283 Recreation Specialist is distinguished from the 3279 Recreation Leader in that the lower class delivers routine recreation programs or activities. The 3283 Recreation Specialist provides specialized programs and is responsible for the planning and administration of the programs.

SUPERVISION EXERCISED

May supervise recreation staff.

EXAMPLES OF IMPORTANT AND ESSENTIAL DUTIES

- 4. Promotes and publicizes programs; prepares marketing material including flyers, schedules of events, brochures and activity guides.
- 5. Supervises, trains and evaluates assigned staff.
- 6. Conducts program administration and registration functions.
- 7. Interacts with community groups and members of the public to keep program elements responsive to community need; builds community support and loyalty for specialized recreation programs.

KNOWLEDGE, SKILLS, AND ABILITIES

<u>Knowledge of</u>: specialized recreation program requirements for a specific program area; methods and principles in conducting program for the target program audience and age cohort; principles and practices of basic first aid; modern office practices, methods, and equipment, including computers; and pertinent federal, state, and local laws and regulations pertaining to the assigned specialized recreation delivery.

<u>Ability or Skill to:</u> design creative and stimulating activities and program elements to meet the specialized recreation program requirements; use database systems (e.g., online database system) for program administration; work effectively and positively with the target population for specialized recreation program; communicate clearly and appropriately orally and in writing; and work independently with minimal supervision.
